2. It may also be noted that the concession of allotment of common symbol to the candidates of a registered un-recognised party under the paragraph 10B of the Election Symbols (Reservation & Allotment) Order, 1968 shall be available to a party only at any **two** general elections to the House of People, **or** any **two** general elections to a State Legislative Assembly or at one general election to the house of the People and the other at a general election to a State Legislative Assembly, as the party may choose. However, if the Party has polled 1% of votes in the last occasion, it can apply again.

3. It may also be noted that the party will have to submit a Declaration confirming authorized office bearers on Commission's record and also attach a declaration of having submitted the requisite Contribution Report, Audited Annual Accounts and Election Expenditure Statement(s) of the Party to the office of Chief Electoral Officer of the State where the Party is having its headquarters. Declaration should be duly notarized and signed by the President or General Secretary or a person holding equivalent level position in the party, as per specimen attached at Annexure-III.
